AB 60 Information Night - Driver's License for Undocumented Immigrants

What: Informational session on how to obtain a Driver's License in the State of California

Who: Office of Assemblymember Nora Campos, Catholic Charities of Santa Clara County, California Department of Insurance, Mexican Consulate of San Jose, California Highway Patrol, Department of Motor Vehicles

Why: To accurately inform the public about AB 60, Driver's License for Undocumented Immigrants

SAN JOSE, CA, December 15, 2014 -- Catholic Charities of Santa Clara County invites the public to an informational meeting about AB 60, which authorizes Driver's Licenses for undocumented immigrants, effective January 1, 2015. Assembly Speaker pro Tempore Nora Campos will co-host the event with Catholic Charities of Santa Clara County, the California Department of Insurance, the Mexican Consulate of San Jose, the California Highway Patrol, and the Department of Motor Vehicles.

People may not be aware or are misinformed about AB 60, which passed on September 12, 2013. The Forum will address what immigrants should expect when they apply for a Driver's License, such as what documents will be needed, and what tests will be required. Attendees will also have the opportunity to ask questions. The San Jose DMV office will open on January 2, 2015. It is one of four dedicated DMV locations in California that will take AB 60 appointments and walk-ins.

Speakers include Speaker pro Tempore Nora Campos, and representatives from California Department of Insurance, the Mexican Consulate of San Jose, the California Highway Patrol, and the Department of Motor Vehicles. Translation will be provided.

AB 60 driver's licenses applications

The California DMV started handling applications for AB 60 driver's licenses in November.

The San Jose DMV office will open on January 2, 2015.

The office will be located at 2222 Senter Road, near other government offices.

You can now apply online for an appointment.

San Jose is one of four dedicated DMV locations in California that will take AB 60 applicants by appointments and walk-in.

All DMV locations statewide will also begin operating on Saturdays to manage the demand for AB 60 driver licenses. Dates and locations will be published online.
