Family Resource Centers: Stephanie's Story

S tephanie's personal journey with Catholic Charities began in 2019. A dedicated mother of three young children, she was diagnosed with depression and her daughter diagnosed with autism. She started as a participant in a variety of programs through our Family Resource Centers -- positive parenting, life skills, digital literacy, and how to support her children's academic success in school. Through meetings and sharing at Parent Café, she became part of a supportive community of other parents. It was a place she describes as "everybody is welcome and belongs." Stephanie became a volunteer in 2020 and joined the staff of Catholic Charities in 2023 as a program coordinator to help other families on their journeys.

"The major difference for me is I feel empowered and I have more options for my life," Stephanie says. "With the help of Catholic Charities staff, my participation and learning has brought peace and stability for me, my family, and my mental health. And our economic stability has improved because now I have a job. My husband tells me how much he appreciates me and that he admires the woman I've become. It was always in me – I just needed an opportunity."

Refugee Foster Care Parent: Kellie's Story

ellie Stafford is proud to say that she recently became a Catholic Charities Refugee Foster Care parent, providing a safe and loving home to an unaccompanied refugee minor. Raising a child takes a village, and Catholic Charities is that village. The program goes beyond just providing homes for refugee boys and girls; it fosters a supportive community, guiding resilient youth as they navigate their challenging transition while also offering unwavering support to foster parents.

"Eight months into fostering an Afghan teenage boy, I am so glad he's safe in my home and that I took the leap to become a foster parent which has given me great joy," Kellie says. "Some days are really hard – for both of us. I see the sadness and separation anxiety he feels, torn away from his home country and unable to hug his parents and siblings. Adapting to life in America has been challenging for him. Yet, every single morning, he wakes up, goes to school, sits through classes in a foreign language, goes to tutoring afterward, and then comes home. He will persevere."

Blossom Valley Grand Opening held for affordable senior apartments

A family services center is coming soon to the property to support critical needs

he grand opening of Blossom Valley Senior Apartments in late March launched the first phase of a multiservice hub that combines affordable housing for low-income elderly residents and critical services for neighborhood children and families in need. The new development is operated and funded through private and public partnerships along with local non-profits, led by Charities Housing and Catholic Charities of Santa Clara County.

The Blossom Valley Family Center will occupy the ground floor of the newly opened Blossom Valley Senior Apartments. Located at 399 Blossom Hill Road in San Jose, this state-ofthe-art facility expands Catholic Charities reach to disrupt poverty in neighborhoods throughout Santa Clara County. Through our Strategic Plan's recently launched initiative, "Footsteps: Pathways to Self-Sufficiency," the Blossom Valley development becomes part of a network of neighborhood-based service locations, which are expanding in a phased approach of piloting and testing, to address the multiple needs of entire families on their journeys out of poverty.

During his remarks at the Blossom Valley grand opening, Catholic Charities CEO Greg Kepferle put the spotlight on the complex's residents – low-income seniors – who clapped and cheered loudly as he thanked them for "welcoming us into their new home." In addition to the residents, others attending the ceremony included Mark Mikl, Executive Director of Charities Housing; San Jose Mayor Matt Mahan; and representatives of local government, businesses and other non-profits.

Blossom Valley Senior Apartments

This new development has 147 apartments for lowincome individuals over the age of 62, and two apartments for the property's staff.

One-third of the apartments will be set aside for Permanent Supportive Housing residents who will be referred by the County of Santa Clara with additional supportive services from Abode Services. Resident

services will be provided through a combination of providers whose expertise is focused on senior health, socialization, and support, with the goal of prolonging senior independence. Catholic Charities will provide staff to perform Service Coordination for all the residents. Service Coordination involves linking residents with existing services within the community.

The building is all electric with sustainable features including: GreenPoint Rated Certification, Energy-Star appliances, energy-efficient light fixtures, low-flow water fixtures, low VOC emitting paint & sealants, nonformaldehyde insulation, energy-efficient windows, drought tolerant planting, solar thermal hot water, and photovoltaic solar panels (common areas).

These newest Blossom Valley units are part of more than 1,500 apartment homes in Santa Clara County currently operated by Charities Housing. With the help of Charities Housing's public and private partners, more 2,000 additional apartment homes under various stages of development or predevelopment that will be delivered into the community over the next few years. This includes a property under construction at 1265 Montecito Ave. in Mountain View where groundbreaking was held in February.

Blossom Valley Family Center

To provide outreach in the ground-floor commercial space of the development, Charities Housing has identified two nonprofit organizations, Catholic Charities of Santa Clara County and Martha's Kitchen, who will provide services for the building's residents and families in the surrounding community.

The Blossom Valley Family Center will be a 5,000-square-foot community space operated by Catholic Charities. It will include multiple small offices, conference rooms, and large community gathering rooms to help guide families and community members through Catholic Charities and partner services. Catholic Charities anticipates our behavioral health services, senior programing, public benefits enrollment, employment and other family supports will operate out of the new location. Services will be provided in partnership with Santa Theresa Parish, located nearby the property; Charities Housing; and several neighborhood associations.

Charities Housing welcomes the surrounding neighborhood associations to use the community room space as neighborhood meeting spaces as well as a gateway to connect with residents.

Martha's Kitchen intends to build an 11,000-square-foot commercial kitchen on the ground floor to prepare meals that will be delivered to those in need throughout the community. They will also operate a food pantry on the premises.

About Charities Housing

Catholic Charities established the Division of Housing Development and Services in 1990 and formed Charities Housing Development Corporation of Santa Clara County (Charities Housing) in 1993 to address the lack of safe and affordable housing opportunities in the community. Current residents of Charities Housing's more than 30 facilities include low-income families, single adults and seniors, and those with disabilities. All properties are professionally managed to compassionately assist residents with their needs. The organization, which currently employs 70 staff members, maintains a reputation in the community for quality construction with limited resources while still achieving attractive modern designs.

What was your initial connection to Catholic **Charities of Santa Clara County?** Being in the TV news business for years in Silicon Valley, I've covered many stories about Catholic Charities of Santa Clara County, from distributing meals, to providing housing, to working tirelessly in servicing those most in need.

Catholic Charities has always been at the forefront of positive news stories. Last year I was approached by Chief Development Officer Susan Lucas Taylor to actually BE involved in Catholic Charities. I was humbled, I was honored, and I jumped at the chance! I wasn't going to just be telling stories about Catholic Charities, I was going to be able to be involved in making a difference!

Is there one area of Catholic Charities community programming that is most meaningful to you?

This Christmas I helped to organize a toy drive for children served through numerous Catholic Charities programs. Thousands and thousands of children received toys, bikes and gifts they would have never received. It brought joy to all involved and now it's going to be a yearly tradition!

What is your personal mission of giving back and what issues are you passionate about?

I was recently visiting my 89-year-old father in the Central Valley. I found myself in his home office, which my mom decorated, looking at the countless plaques that adorned his walls. I stepped back and really took note of all the accolades of involvement he had in his community throughout the years: hospital boards, church financial boards, volunteer activities, charity events and more. His wall was filled with recognition for his non-profit work! Then I stopped to realize, I am who I am because of him. He never boasted about his involvement, he just acted, and as a child I grew up learning this through his example. I now give my time because he gave his. He set up a pattern of serving in his life and leading by example. I'm happy to follow in his footsteps, and I'm thrilled to be working with Catholic Charities. I hope to lead by example for my own children. In giving, you truly receive.


