
Catholic Charities' CORAL kids have been participating in the Tech Challenge for more than 10 years. Each year, more students sign-up and are excited to see where their

### Message From the CEO GREG KEPFERLE

#### **An Abundance of Mercy**

Dear Friends,

Have you ever been overwhelmed, not by the challenges we all have to face, but by all the good that is pouring out into the world? Last month, I accidently received an abundance of mercy. It all started innocently enough with an email inquiring how volunteers could help the young children and their parents who were being separated at the border as they sought safety from violence in their home countries. Somehow my name got attached to an email request for volunteer attorneys and therapists to help out. Then another kind soul turned it into a Facebook post and encouraged others to copy and send. Before I knew it, I was inundated with kind offers via phone calls and emails from across the country. Attorneys were ready to jump on planes. Therapists were ready to close their practices for days to help. A day care center operator was ready to temporarily close down to provide early childhood help. Donors offered to pay for travel costs. An abundance of mercy!

While we are trying to help our sister Catholic Charities agencies assist the families at the border, I am also encouraging volunteers to support their own local Catholic Charities that already do so much for children and families facing crisis due to their immigration status, homelessness, mental illness, disabilities, incarceration, or poverty.

We celebrate an abundance of mercy here at home. I am thrilled that we celebrated 50 years of Handicapables providing spiritual and social support to capable individuals who happen to have a disability. We are also continuing to build new affordable housing through our Charities Housing Development Corporation. Our CORAL summer school provides a safe place for children to learn throughout the summer while our senior services continue to provide opportunities for wellness and socialization. Meanwhile, we continue to respond to the needs of immigrants and refugee foster youth, as well as the families displaced by last year's flood. We provide healing to individuals and families affected by mental illness even as we prepare to launch our new House Sharing program.

Thank you to all of our generous donors, funders, volunteers, and supporters as we provide an abundance of mercy by changing lives for good. I invite those new to Catholic Charities to come and see mercy in action.

# Catholic Charities Named 2018 Non-Profit of the Year

Catholic Charities received the Silicon Valley Organization's 2018

Non-Profit of the Year Award during a ceremony on April 5, 2018 that also recognized outstanding leaders and organizations in the business community. Catholic Charities' Board President Khanh Russo and Vice President Veronica Duluk received the award on behalf of the agency, along with Division Director of Emergency Programs & Housing Services Lindsey Caldwell and CEO Gregory R. Kepferle.

Specifically, it was Catholic Charities' outstanding efforts in helping the vulnerable in our community—especially the survivors of the devastating Coyote Creek Flood in early 2017—that brought the agency recognition. Focusing on the holistic approach of servicing all aspects affected by the flood, Catholic Charities provided survivors with disaster case management, financial assistance, car purchasing assistance, and mental and spiritual support in English, Spanish, and Vietnamese.

"It is gratifying that the business community recognizes the importance of the ministry of the Catholic Church in helping people of all cultures and beliefs through the great work of Catholic Charities, including our response to disasters," said Kepferle.

Whether during times of a community disaster or the individual crises that affect so many families, older adults, and children in our community, Catholic Charities is there to provide services in five critical areas: food, housing, health, education, and economic security. For over 62 years, the organization has worked to build a just and compassionate community by alleviating, preventing, and reducing poverty.

### **Charities Housing Breaks Ground for Senior Housing**

For seniors living in the Bay Area, the comfort of home can often feel scarce as housing costs continue to rise. Through community partnerships, Bay Area organizations are coming together to build permanent homes and create spaces of community for our senior population.

On April 19, award-winning nonprofit Charities Housing celebrated the groundbreaking of The Veranda, its newest affordable housing development for seniors 62 years and above. Featuring 18-studio apartments and a two-bedroom staff unit, The Veranda is designed with seniors in mind. Each studio supplies energy-efficient kitchen appliances, ADA accessible bathrooms, heating and air conditioning, and a private patio or balcony.

The community-oriented development offers amenities such as an

outdoor terrace, events
room with a kitchen, shared
laundry room, and a spacious
lobby. The location is prime,
set right across from Main
Street Cupertino with access
to public transit, groceries,
a health clinic, parks, and
numerous retail stores and
restaurants.

Present at the groundbreaking ceremony were representatives of Charities Housing, County of Santa Clara Board of Supervisors, City of Cupertino, Assemblymember Evan Low's office, Assembly member Ash Kalra's office, Wells Fargo, and Housing Trust Silicon Valley.

The goal of the project is to achieve 100% occupancy by May 2019. Through the 2016 Measure A Affordable Housing Bond in Santa Clara County, six of the apartments will be reserved as permanent supportive housing for formerly homeless/special needs seniors. The Veranda is one of the first projects in the County to have been awarded the funds.

"Charities Housing recognizes that affordable housing is essential to fostering and maintaining an equitable, diverse, and inclusive community," said Dan Wu, Executive Director of Charities Housing. "We are thankful for the opportunity and support from our public and private partners."

Established in 1993 by Catholic Charities of Santa Clara County, Charities Housing's mission is to develop, manage, provide, and preserve high quality affordable housing for low-income individuals and families. Through enhanced property management and structured resident

## One World Cup Unites Local Refugee and High School Youth

While much of the world closes its doors to refugees, Catholics across the globe continue to welcome them with open arms, or in this case, soccer fields. On April 28, 2018, five South Bay Catholic high schools partnered with Catholic Charities of Santa Clara County to host the second annual "One World Cup" at Archbishop Mitty High School in San Jose, CA. The game benefits refugee foster youth living in the Bay Area and brings together youth of different backgrounds through the universal language of soccer.

Refugee youth from as far as Eritrea to Afghanistan to India marched alongside student athletes representing Archbishop Mitty, Bellarmine, St. Francis, Notre Dame, and Presentation high schools in a show of solidarity before kicking off the match. The audience



cheered and roared, holding up colorful signs that read "One Love," as the players donning white and blue tees scattered across the field.

"This is a wonderful opportunity to stand with refugees, to let refugees in our community know that they are welcomed and valued," says Angela Albright, Division Director of Refugee Foster Care. "There is still a lot of uncertainty in our country's climate on the overall view of the

refugee crisis, and now it is more important than ever to stand in solidarity and show our support through unifying events like this."

One World Cup began in 2017 by Archbishop Mitty students who were inspired to rise to action to fight for the rights of refugees in response to legislative policies banning refugee migration to the United States. The inaugural game gathered over 100 community members and has since expanded to involve athletes and audience members representing five South Bay high schools.

## **Bringing Everyone's Strengths Together at Youth Center**

What's best for our youth? According to the City of San Jose's latest evaluation report, the Bringing Everyone's Strengths Together (BEST) program has made significant strides in positively impacting local youth through gang prevention programming.

The BEST Final Evaluation Report for the 2016-2017 program year reflects the City's commitment to deliver services to youth who are most vulnerable to gang involvement. Key findings show youth reporting higher rates of change compared to the previous year across every measurement. This year, 77% of youth expressed an increased ability to connect with adult allies because of their involvement in BEST programming, an increase of 17% from the previous cycle. In addition, 77% of youth said that they feel prepared to succeed in the community because of BEST services.

In fiscal year 2016-2017, Catholic Charities served a total of 953 unduplicated program participants. Of those 953 clients, 96% expressed that their ability to stay safe was better, and 99% expressed being more successful at school or at their job due to BEST programming. According to the agency score card, Catholic Charities earned a high satisfaction score, with children

and youth rating the program between excellent and good, and reported feeling that they had benefited from the program.

"BEST makes a difference for our youth every day," says So'o Poumele, BEST Program Manager. "Youth are getting re-connected to their school, adults, and their peers. We support them to feel prepared to succeed, and thrive with and in their community."

In partnership with the City of San Jose, Catholic Charities of Santa Clara County provides truancy, gang prevention, and intervention services to at-risk youth through BEST programming offered at the Washington United Youth Center (WUYC). WUYC provides a safe haven for thousands of youth seeking refuge from the streets. Our programs work with at-risk youth who face challenges that may include homelessness or addiction among family members, and offer resources, support, and lasting friendships among counselors and peer youth.

## **CURRENT TAX LAWS CAN BENEFIT YOU AND THE COMMUNITY**

The Tax Cuts and Jobs Act ("The Act") that took effect this year has inspired many questions about giving, specifically as it relates to the charitable deduction on your income tax returns. Charitable deduction limits increased, which is nice, but so did the federal standard deduction, resulting in less tax incentive to give. This is especially true for taxpayers who pay little or no mortgage interest and don't have significant medical expense deductions. Without one of these, most taxpayers will be claiming the standard deduction instead of itemizing.

To maximize the income tax benefit of charitable donations, donors can make significant gifts in one year and small-to-no gifts in other years. In the years they make the donation, they would itemize deductions. In alternating years, they would claim the standard deduction. While this tax strategy works for income tax purposes, it puts a tremendous strain on Catholic Charities, since the people who rely on our services need help daily, not every other year.

So how can you maximize the tax benefits of your charitable deductions, keep tax filings simple, and continue to support Catholic Charities and other causes you care about annually?

The solution could be a donor advised fund. Donor advised funds are like charitable checking accounts with donations that:

- Act like irrevocable deposits,
- Are fully deductible at the time you make the gift, up to the deduction limits,
- And allow you to make distributions to nonprofits as you wish.

We recommend consulting your tax and financial advisors to determine a giving amount that makes sense for you and creates optimal tax deduction opportunities. Then using that budget, open a donor advised fund like those offered by the Catholic Community Foundation of Santa Clara County. Once established, you can make gifts like your annual Caritas membership renewal from your donor advised fund to Catholic Charities, or any other charitable organization of your choosing.

This is a win-win: you take advantage of The Act's increased standard deduction while still helping your neighbors fight poverty every day.

### Volunteers Needed to Help Distribute Food to Low-Income Seniors and Families

Catholic Charities Supportive Housing Services needs volunteers to help with monthly food distribution to low income seniors and families.

"Through this program, extremely lowincome residents have access to free, fresh, nutritious fruits and vegetables to maintain as healthy a diet as possible," said Consuelo Collard, Program Manager for Supportive Housing Services. "It allows individuals and families to meet their financial obligations without having to decide between buying food and paying rent."

In partnership with the Second Harvest Food Bank (SHFB), the "farmer's market" takes place monthly at two facilities—San Antonio Place in Mountain View and Kings Crossing Apartments in San Jose—which are operated by Charities Housing. Residents of these facilities and two other facilities receive food through this effort. Thousands of pounds of produce have been distributed since the program began four years ago.

"The residents who benefit from the SHFB fresh produce mobile rely on it to help them get through the month and stretch their food budgets, and are very grateful to have access to the food," Consuelo explained.

However, a lack of staff with the physical strength to unload and handle the heavy boxes of produce has limited the expansion and scope of distribution. Previously, food pantries were operated at four Charities Housing locations stocked with food that was picked up twice monthly from the Food Bank. But a lack of manpower forced this service to be stopped.

## CATHOLIC SOCIAL TEACHING ON REUNIFYING FAMILIES

All social, economic, and political rights and responsibilities flow from the central affirmation that all beings on the planet, including the planet itself, has the fundamental right not simply to live, but rather, flourish—in Catholic social doctrine—the Right to Life. The right to life is inseparably tied to the quality of living, or dignity of life. We believe that to be human is to be a member of a family and community. Thus, the administration's policy of separating families was seen by the Bishops and leaders of other faith communities as immoral.

Human beings are formed, nurtured, educated, and socialized by belonging to families, specifically one's parents. The administration's policy of separating children from their parents was in clear violation of the fundamental human right to participate in family. At the time of writing this article, the administration has been very slow in re-uniting parents with their children. Respected human rights organizations have criticized the administration for making the return of the children separated from parents conditional upon parents signing a "Parent's Separated Removal Form." By signing this form, parents in effect forfeit their asylum claims. They can either return to their country with their children or leave their children in the United States and forfeit parental rights.

The Catholic Bishops, Catholic Charities USA, clergy and women's religious orders have taken a strong position not only against the president's policy of separating families, but also in the treatment of children currently held in detention centers, the dubious practice of trying toddlers in immigration court, the narrowing of restrictions of asylum seekers that target refugees from Latin America, for coercing asylum seekers to forfeit their right to seek asylum as a condition for family unity, and the inexcusable delay in reuniting children to their parents.

# Step Up Silicon Valley Celebrates 10 Year Anniversary and Launch of New Initiative

The affluence of Silicon Valley often hides the reality of poverty among us. Step Up Silicon Valley, the poverty-fighting arm of Catholic Charities of Santa Clara County, has left its mark as a social innovation network that ignites ideas and turn them into action. On May 16, 2018 Step Up Silicon Valley celebrated its 10-year anniversary at Santa Clara University with the launch of the Nonprofit Data Integration Technology project.

Across the span of a decade, Step Up has worked to learn about the complex issue of poverty and the barriers that organizations face to serving the most vulnerable members of the County of Santa Clara. Collaborative initiatives such as 1,000 Out of Poverty brought to light the challenge of data intake and collection—clients seeking help from multiple agencies must share their information multiple times to receive various services, while service providers must enter data twice on different systems to get funded or cannot share client data because of incompatible software.

With seeding funding from Cisco Systems, Step Up worked closely with technology vendor ThingLogix and its agency partners Next Door Solutions to Domestic Violence, The Bill Wilson Center, Catholic Charities of Santa Clara County, and The Stride Center to complete the development and implementation of a Data Integration System that addresses this ongoing problem.

Built on ThingLogix Foundry Platform, the innovative technology will provide a collaborative system permitting nonprofit agencies to work together with shared clients.

Step Up received a commendation from Santa Clara County for its 10 years of innovation and impact. The event also honored exiting Senior Managing Director, Almaz Negash for her eight years of service with Step Up Silicon Valley.

"Challenging poverty itself can seem like jousting at windmills," says Negash. "But even a small team of passionate, smart, committed partners and unlikely allies can make an incredible difference in changing social policy and finding new approaches to tackling poverty."

# Catholic Charities and Santa Clara County Launch New House Sharing Program

Catholic Charities recently launched a new House Sharing program with the County of Santa Clara. The agency matches people willing to rent a room in their home with people seeking affordable housing. Catholic Charities is the trusted matchmaker to ensure the room providers and renters are screened and compatible.

The pilot program has a goal of matching 100 households (renters with providers) each year over the next two and a half years. The Board of Supervisors approved a contract of \$1.5 million with Catholic Charities to launch the new House Sharing Program on April 3, 2018.

Priority for rooms will be given to County residents with incomes below the area median income. In particular, young adults and seniors may find this a helpful solution to their housing costs. Seniors who are "house rich but cash poor," who own their own homes but have vacant rooms, may find this option not just an attractive source of revenue, but also an opportunity for creating new friendships.

Catholic Charities will conduct marketing, outreach, facilitate the housing agreements, screen the providers and the renters through background checks, and will provide advice and support to the participants. House Sharing is a County program administered by Catholic Charities.

#### WHAT IS HOUSE SHARING?

House Sharing is when two or more unrelated people share a home. This could be a homeowner or renter (House Provider) renting out vacant bedrooms to a person (or persons) seeking housing (House Seeker). It could also include two or more people renting a home together. Each resident typically has his or her own bedroom, but shares the home's common living areas (bathrooms may be private or shared, depending on the property).
