# Feeding Our Community One Meal at a Time



n an area with incredible wealth, we also have many community members who experience devastating hunger and poverty. Thanks to our caring volunteers and staff, last year we served more than 575,000 warm and nourishing meals to our neighbors in need through our various nutrition programs.

At Catholic Charities of Santa Clara County, we provide low-cost hot, nutritious meals to seniors in need who attend our Eastside Neighborhood Center in East San Jose and our John XXIII Multiservice Center in downtown San Jose. Our Senior Nutrition program serves more than 70,000 meals each year.

To help low-income children throughout the county, we provide healthy meals and snacks to the kids who participate in our free Communities Organizing Resources to Advance Learning (CORAL)

K-8 after-school program, which is located at 22 sites. In partnership with the San Jose Unified School District and the Franklin McKinley School District, we serve over 1,900 students on a daily basis during the school year. In the summer, we serve over 600 students.

It is not easy to make ends meet in this valley, and we know that many families have parents

who often work more than one job, who struggle to decide whether to pay for rent, health insurance,

In addition, we have community gardens that people can use at our Franklin McKinley Children's Initiative, Eastside Neighborhood Center, and Dahl Family Resource Center.

Thanks to funding from Catholic Charities of California, we offer Supplemental Nutrition Assistance Program Education (SNAP-Ed), which helps people lead healthier lives. In addition, we established healthy eating policies at 13 locations serving youth in the community.

#### FOOD

When you or your children are hungry, life's challenges are even more difficult to overcome. We serve over 575,000 meals to more than 10,000 of our neighbors in need each year, preparing hot meals at our senior centers, distributing free grocery bags at our community centers, and providing nutritious snacks for our after-school students daily. A hearty meal goes a long way for those who endure hunger each day. By nourishing the body, we nurture hope and nourish the soul for our neighbors in need.



#### HEALTH

*Health and well-being take many forms, from the physical to the emotional.* Seniors receive wellness assessments and nurse check-ups, individuals and families access counseling, frail adults are cared for at our Adult Day Care centers, and young men and women attend peer support groups and gang prevention to place them on a path to healthy adulthood. Health is wealth–we care for the well-being of our community members to foster holistic strength.

#### HOUSING

*Our region's housing crisis means that families are often crowded in shared apartments with other families, live in converted garages, or sleep in cars. This is not home.* Our housing programs provide support for families and individuals facing housing instability or homelessness, from case management to housing placement for flood survivors to supportive services at Charities Housing sites, to direct financial assistance to keep people in their homes. Neighborhoods are assisted to address unsafe and blighted properties. Home is a place of love, belonging, community, and safety, not stress, fear, or instability. We provide comfort, respite, and the daily blessing of home for those who are without.

#### **EDUCATION**

*Education opens doors to opportunity and life-long learning.* Our after-school expanded learning program, CORAL (Communities Organizing Resources to Advance Learning), serves 2,500 youngsters in high-needs neighborhoods

#### every year with literacy and STEM programs, sports, and enrichment activities. Our Family Resource Centers provide parenting education and early childhood programs, while senior and neighborhood centers host classes and workshops, and ESL instruction helps participants to navigate civic processes and connect to the wider community. Our programs open doors to educational pathways leading to stability and self-sufficiency.

#### **ECONOMIC SECURITY**

Income is the key to self-sufficiency, the key that will unlock all of the above for people living in poverty. Our employment programs specialize in placing those with severe barriers to employment, securing jobs for over 100 people every year, while our Financial Education programs help participants to budget, save, and plan for their future. We assist our immigrant neighbors to obtain legal status and citizenship to secure employment and engage in the community, and help refugees fleeing violence and instability around the world to build a new life in our beautiful and vibrant Santa Clara County. Our participants pursue meaningful career opportunities and professional development that fosters skill sets and drive. We support our community members to seek and sustain a reliable income to achieve long-term stability.

## **CORAL STUDENTS DECK THE HALLS (AND TREES!) WITH TECH**

Back by popular demand, our CORAL after-school students will once again participate in the Christmas Tree Ornament programming project. The goal of the project is to introduce students to "coding" skills. Each student programs a lighting sequence for a microprocessor controlled tree ornament that is hung on a tree throughout the holidays at San Jose's Christmas in the Park event. Thanks to growing donor support, this year 125 students will have this fun opportunity to learn about computers, programming, circuits, variables, functions, light colors, and more.

According to Aldo Estrada, STEM Curriculum Manager for CORAL, "Participation in the Christmas Ornament project turned out to be an incredibly memorable experience. Sometimes it can be difficult to explain STEM curriculum and its significance to parents, however, the value of the ornament project was very tangible to both students and parents."

At the culmination of the project during the Thanksgiving weekend, with families in attendance, each student will place their special ornament on their school's designated tree. The brightly lit trees will be on display for the duration of the holiday season, serving as a source of both great personal and family pride.

This project is a great example of how Catholic Charities partners with the community and thinks creatively to provide enriching learning opportunities for students in need. And it illuminates the fundamental value of Catholic Charities programs to individual and corporate supporters.


- Gift cards to stores (especially Target, Walmart, Safeway, and gas cards)

# Financial Foundations Initiative Empowers Participants

In her early 70s, Lana dreamed of a vacation to visit her sister in Fresno, who she had not seen for many years. But living on a fixed income prevented Lana from pursuing her dream. Between cost and distance, it seemed financially impossible, until one day, Michael Carter, Program Supervisor of Catholic Charities' new financial education program, suggested, "Let's figure out a budget for that. Let's talk about having you go on a train to see your sister." Lana's eyes lit up with joy.

The Financial Foundations Initiative teaches basic money management. Participants learn how

### **PARTNERING WITH PARISHES**

Tens of thousands of our neighbors live in extreme poverty and they turn to our parishes for support. Parish offices are inundated with requests to help with groceries, rent, transportation, and utilities. Parishes play a vital role in the well-being of those in need; however, most parishes do not have the capacity to do a needs assessment on clients, the resources to help people enroll in social programs, or personnel for longer term case management.

Through interviews with clergy, lay people and volunteers who serve in St. Vincent de Paul and food pantries, I heard many people say that they would like Catholic Charities and parishes to work more closely together as a way to do more than give people a hand out. I heard many people from other parishes say they want to work directly with those in need. One person said, "I live in a bubble. I know that there are people in need and I want to do more than just help them, I want to know them."

Inspired by Pope Francis' teaching that an "encounter" between people of different backgrounds will lead to mutual and eventually systemic transformation and the words of St. Paul, "We are no longer strangers, but friends," Catholic Charities will pilot a partnership in East Side San José (Deanery Six) that will put people on a pathway toward self-empowerment through creating a network of existing and new volunteers who will be trained to do a basic needs assessment and help connect people to social service programs run by Catholic Charities or other agencies. Catholic Charities will be dedicating personnel toward this effort to facilitate training and supervision of volunteers and the administration of the program. With faith in God and the collective strength of parishes, the community, and Catholic Charities, all things are indeed possible. ¡Si se puede!

## SILICON VALLEY COMMUNITY FOUNDATION AWARDS CATHOLIC CHARITIES IMMIGRATION LEGAL SERVICES

Silicon Valley Community Foundation (SVCF) has awarded Catholic Charities Immigration Legal Services (ILS) \$460,000 to support the work of the South Bay Legal Immigration Services Network. The collaborative is comprised of nine immigration legal service organizations in Santa Clara County, with the goal of improving access to quality immigrant legal services and community education for immigrants and refugees through service coordination, common capacity-building, and project collaboration. These services help immigrants and their families improve their immigration status and become more aware of their individual rights and responsibilities as members of the community. SVCF recognized the work of ILS and other organizations at their annual Legacy Society event on September 5.

to manage their finances, save, and set long-term and mid-range financial goals that enable them to turn dreams into reality. Whether it is owning a home, affording clothes, or saving for a vacation, the program seeks to encourage participants to envision a goal and teach them the financial mechanisms to make it happen.



Mike and Lana worked together to develop a budget for a five-day trip to Fresno via train with enough saved for Lana to visit restaurants and do some sightseeing with her sister. The trip amounted to approximately \$400, and for Lana, this was a lifelong dream that she achieved on her own, with the help of Catholic Charities.

With anchor funding from Citibank Community Development and additional support from Wells Fargo, the program is set to meet its goal of serving 75 clients with one-on-one coaching by June 2019.

"Nobody wants to save for a rainy day," says Mike, "But people should save for something good, because if something bad happens, you have money for that, too."

# Restorative Justice Center Helps Adults Change Their Lives for Good

Catholic Charities' Restorative Justice Center helps adults with a criminal background change their lives for the better. The Center takes a more holistic approach to healing, recognizing that program participants often turn to crime, drugs, or alcohol as a result of past challenges or trauma. Through access to various social supports, the program stabilizes lives for recovery and successful reintegration into the community.

**Bridges of Hope** is a faith-based re-entry program. The program provides case management services and faith-based services to men and women coming out of Main Jail and Elmwood Jail. They also help with basic needs and connect participants to additional community services.

**Bringing Everyone's Strengths Together** (**BEST**) provides case management and social opportunities for young men and women ages 12-24, who live in six local hot spots that have been identified as being highly impacted by gangs and police involvement. The program is based out of Washington United Youth Center.

**PRO-GRIP** provides therapy, intensive case management services, and social opportunities to youth ages 14-21 who are on Juvenile Gang probation. The program is offered throughout Santa Clara County.

**Support and Enhancement Services (SES)** provides therapy, case management services, and social opportunities to youth ages 12-18 who are on Juvenile Probation. The program is also offered throughout Santa Clara County.

Inmate Services provides light case management services, referrals to legal services, linkage to reading materials, linkage to eyeglasses, linkage to faith-based services, and linkage to family members in the community are provided to men and women who are at Main Jail or Elmwood Jail.

**Right Directions Program** clients come from prison, jail, and AB109 (Assembly Bill 109 diverts people convicted of certain classes of less serious felonies from state prison to local county jails). Full scope employment services are provided, including Job Readiness/Job Preparation, Job Development, Job Placement, and Job Retention. Tattoo removal is also provided for life

## FRANKLIN-MCKINLEY CHILDREN'S INITIATIVE CELEBRATES FAMILY RESOURCE & WELLNESS CENTER GRAND OPENING

Franklin-McKinley Children's Initiative, a program of Catholic Charities of Santa Clara County, in partnership with FIRST 5 Santa Clara County and the Franklin-McKinley School District (FMSD) celebrated the grand opening of two new neighborhood resources and support services at Daniel Lairon College Preparatory Academy on September 18. The Seven Trees Family Resource Center works closely with parents and the community to promote their children's development, ensure their children are ready for school, build strong family relationships, and create a connected community. The Wellness Center provides mental health and student support services for children attending FMSD schools, with community-based services provided by School Linked Services and Uplift Family Services.

Each day, Rayi goes to school with a smile. His parents are proud because at the age of 12, it is the first time that he has ever attended school. Diagnosed with down syndrome and cerebral palsy, he was unable to attend school in Afghanistan due to a lack of special education services. But through the help of Catholic Charities' Immigrant & Refugee Integration Services (IRIS) and the Car Donation program, Rayi is enrolled and attending school for the very first time.

IRIS provides displaced families with an array of services, including housing, ESL tutoring, cultural orientation, transportation assistance, job training, referrals to community resources, and case management. These services are made possible through Catholic Charities' Car Donation program. For 17 years, Catholic Charities of Santa Clara County has accepted donations of all types of vehicles that directly help families and individuals in need within Silicon Valley onto paths of self-sufficiency.

Rayi is one of a family of eight whose parents greatly value education. His father, Isaad, was a veterinarian and professor in their regional university in Afghanistan. Both parents made an extra effort for their older daughters to attend college and take extracurricular English language classes. Now, Rayi has access to the resources that he needs to learn and thrive.



"I am so happy with the services that Catholic Charities has provided to my family," says Isaad. "My case manager knows so much about my religion and culture. It makes me so surprised, but so happy. The best is that my case manager has helped enroll my children in school, even my 12-year old son with a disability. September is the first time my son will be going to school. Every day he goes with a smile. He loves it!"

## THE HEALTH TRUST TRANSFERS SEVEN FAMILY RESOURCE CENTERS TO CATHOLIC CHARITIES

The Health Trust recently transferred seven Family Resource Centers (FRCs) to Catholic Charities. FRCs are a place-based strategy to strengthen communities by investing in families with young children living in high-risk neighborhoods. FRCs offer parenting and child enrichment classes; screenings for oral health, vision, hearing, and development; health and nutrition information; resource and referral assistance, and more, all free of charge. The Health Trust previously managed six centers and co-managed one site with Catholic Charities before determining the transition as the best alignment for their new strategic plan focusing on health prevention and support among specific populations. Catholic Charities now manages 11 of the 17 FRCs in the County of Santa Clara.

We all know that education is one of the greatest equalizers, the best escape route from a life of poverty. However, research shows that people struggling with poverty are less likely to achieve a college education. In East San Jose, the Franklin-McKinley School District has a population of 7,500 elementary students; 45% are English language learners and 77% are from low socio-economic status. The needs of these students and their families are high and the demands on the school district are great.

On September 10, 2018, Catholic Charities' Distinguished Giving Committee Co-Chairs, Judy Marcus and Mike Pope, hosted a conversation to discuss education for our poverty challenged youth. Juan Cruz, Superintendent of the Franklin-McKinley School District, launched the dialogue and highlighted the long-standing partnership between the school district and Catholic Charities of Santa Clara County. For many years, the agency has supported the community with Family Resource Centers, Prevention and Early Intervention Programs, and Academic Support through the CORAL (Communities Organizing Resources to Advance Learning) after-school program. Thirty guests participated in an intimate dialogue that brought greater understanding of the challenges and needs of poverty challenged

It is the memory of their beloved son, Joseph Harold LaScola, which inspires and motivates the philanthropy and volunteerism of Joseph A. and Emily LaScola.

"The work of Catholic Charities and local parish outreach programs personify Joseph's way of helping those less fortunate than himself," the LaScolas said.
