

FROM THE EXECUTIVE DIRECTOR

Dear Friends,

s we begin moving into holiday season, such as it is in this year of pandemic, I can only say that I am so thankful. I am grateful for each of our generous donors, for our faithful volunteers, for our committed public, private and nonprofit partners, and most of all, for our amazing staff. Throughout the past eight to nine months, they have made the "pandemic pivot" to provide disaster assistance with courage, compassion, good humor and grace.

This "pivot" meant that we significantly expanded our emergency food distribution, and in the past eight months have fed over 400,000 individuals, ten times more people than the agency served in all its programs in the previous year. As more seniors came to us homeless and hungry, we expanded our senior nutrition with "grab and go" meals outside of John XXIII Multiservice Center and Eastside Neighborhood Center, and our homeless services at The Window increased by 50%. We continue distributing food boxes at eight Family Resource Centers. Thanks to the amazing partnership with Second Harvest and with courageous volunteers in seven parishes, we continue to provide home delivered groceries to seniors and "touchless drive-through" groceries to hundreds of families at parishes six days a week.

The "pivot" meant that, thanks to Governor Newsom and Catholic Charities of California, we were able to distribute \$6 million in state funds to 12,000 immigrant families in six weeks. Thanks to generous donors and the City of San Jose and other partners, we are also providing over \$7 million in rental and financial assistance to needy families through the end of December. And thanks to the generous and creative partnerships of community-based organizations, the public sector, academia, philanthropy and businesses, we are helping build the **Bridge to Recovery network to move families out of the economic crisis of the pandemic** through a stronger integrated safety net and workforce development system.

Thanks to the creativity of staff, the "pivot" means that we have been able to continue most of our services either remotely or through a hybrid model of remote and in-person services like our CORAL after school program, Youth Empowered for Success and Behavioral Health Services.

Thanks to the generosity of our donors, the "pivot" means that even though we weren't able to hold our annual bocce fundraiser, **donors are increasing their gifts to help us meet the massive demand.** Thanks to your generosity our staff are able to respond with agility, skill, courage and compassion.

Finally, I encourage all our supporters to continue to invest through Catholic Charities in the amazing families we serve. For these are the ones who have had to **learn how to pivot the most** as they face unemployment, hunger, the loss of health insurance, the potential loss of their homes, the stress of trying to care for their children at home while trying to find work, and increased anxiety and depression related to unemployment and the uncertainty of the pandemic. Please keep them in your prayers. And please be generous. Thank you!

Parish Engagement Program recognized in Catholic Charities USA Innovation Challenge

atholic Charities Parish Engagement Program was recently recognized as a finalist in Catholic Charities USA's Innovation Challenge and grant competition among its peer nationwide affiliates seeking innovative, replicable, scalable solutions to moving individuals and communities out of poverty. The team received numerous inquiries and was quickly invited to present the program in greater depth on a national webinar. The program received a \$100,000 grant as part of the competition from Catholic Charities USA.

The program is designed to tackle poverty through community building, direct services and referrals, and establishing long-term deep connections between volunteers and those seeking pathways to self-sufficiency.

In its first six months at its pilot location at Our Lady of Refuge Parish, 80 volunteers had already been trained and 1,800 participants served. Since the onset of the COVID-19 pandemic, the program has gained 268 volunteers, with another 265 in process, and has served an average of 1,200 people per week. Director of Advocacy and Community Engagement Fr. Jon Pedigo and Program Manager Bridget Balajadia lead a small but focused team that is expanding the Parish Engagement model into new neighborhoods and extending capacity with each new volunteer.

CORAL program pivots in new learning environment as pandemic moves schools online

ince the pandemic shutdowns in March, Catholic Charities has mobilized agency resources and realigned staff to deploy a rapid response to the ongoing crisis.

Education is one of five Catholic Charities focus areas – along with food, housing, health and economic security – and the agency's 140 CORAL after-school instructors continue to meet the emerging needs of families impacted by COVID-19. In pre-pandemic times, CORAL (Communities Organizing Resources to Advance Learning) operated after-school learning programs in 22 schools and one community center serving students

daily in kindergarten through eighth grade.

"This school year, we are committed to supporting families, many who were already struggling to make ends meet, with new and creative ways for children adapting to a new learning environment," according to CEO Greg Kepferle. "Our focus continues to be supporting our most vulnerable student populations."

Starting in late August, CORAL instructors are providing in-person programs at 10 public schools in the Franklin-McKinley School District (FMSD) for high-needs populations of students including: homeless students, special-education



qualified, higher academic needs, and the siblings of these students. Instruction takes place under strict public health guidelines while working in "stable cohorts" which are small social bubbles, advised by health experts since the beginning of the COVID-19 pandemic as a mechanism to keep interactions with others low. The CORAL staff are not acting as teachers but rather are supporting the students in their learning, as well as conducting activities for the students during the class breaks.

"Students arrive at school in the morning to attend their virtual class with their school day teacher. In the stable cohort, there is a **CORAL After-School Instructor** with them for support during the synchronous and asynchronous classroom activities," according to America Aguirre Gomez, CORAL Managing Director. "The CORAL inperson program continues to work closely with school district staff and teachers to deliver programming to support students with academic needs, homework assistance, and connectivity."

In addition, CORAL provides after-school distance learning at four public schools in the San Jose Unified School District, and five public schools and three charter schools in the Franklin McKinley School District.

The curriculum for afterschool includes pre-recorded guided activities for students and parents to access anytime at home, including art and STEM projects as well as enrichment activities such as music and dance. Reading and academic activities are also developed and provided. Students have participated in activities such as a virtual tour of the San Jose State campus and experiencing the Monterey Bay Aquarium online.

CORAL staff also prepares activity kits with instructions and materials for students and families to pick up at school sites or to receive via home delivery. Kits included STEM, literacy, and art projects that can be done independently or used in conjunction with pre-recorded guided activities.

Beyond academics, one of the most important roles of CORAL instructors is providing wellness check-ins for families.

CORAL staff is assisting parents and caregivers to adapt







to online learning methods, including support with technology, platforms/applications, tips, and best practices for supporting their children's online learning. Staff also conduct "wellness check-in" calls for students and families to assess concerns, barriers, and family circumstances that may impact students' participation and learning. And each student in the program has a one-on-one with his or her CORAL Afterschool Instructor for 30 minutes once a week.

America adds, "Especially during these uncertain times, our families are very grateful in having a place where their students can get support and have a safe place to be during the day."

Corporate Partners: San Jose Earthquakes

For the first time, the San Jose Earthquakes and Quakes Foundation have joined forces with Catholic Charities of Santa Clara County. This partnership is rooted in a mutual goal of addressing food insecurity and fighting poverty in the Bay Area.

In July, the San Jose Earthquakes launched "Pledge 74" with a goal of raising \$740,000 towards the cause, and increasing

awareness and volunteerism to address these critical needs in our community. The Earthquakes activated their front-office staff and die-hard cheering section fans to volunteer multiple times in August at Catholic Charities food distribution sites. Those days of volunteering added up to 284 hours of community service and helped distribute an estimated 133,000 meals to the community!



Currently, Catholic Charities is providing more than 114,000 meals weekly across six food distribution sites in Santa Clara County. These sites are manned by a small army of volunteers – including the San Jose Earthquakes – who help register, organize, and place groceries into long lines of cars awaiting their week's supply of food.

Pandemic, tax law changes shift the landscape for year-end donors

ith year-end approaching and tax law changes in 2020 in response to the pandemic, it's easy to get confused about giving and charitable deductions.

Know that giving through Catholic Charities to support those most impacted by the pandemic and economic uncertainty is always a clear investment, one that awards dividends far beyond your financial bottom line.

Here are a few things to remember when considering your giving before the end of 2020:

- The CARES act allows anyone, even those who do not itemize on their tax return, to deduct up to \$300 in charitable contributions.
- Required minimum distributions have been suspended in 2020. That said, distributions from your IRA to Catholic Charities remains a great way to support our poverty-fighting work.

- · Despite a hyperactive year in the stock market, appreciated securities remain a great way to give more, pay less, and avoid capital gains taxes.
- For the most generous, the CARES act raised the maximum charitable deduction amount to 100% of your income (cash donations only). At year end, you may have a clearer picture of your household annual income, making the planning of charitable giving more accurate.
- Using your donor advised fund ("DAF") to support Catholic Charities is still a great way to put your philanthropic dollars to work. We encourage you to use your DAF to give rather than save since giving is your DAF's ultimate purpose. Note that you may only deduct up to 60% of your annual gross income for cash contributions to your DAF.
